Communications between Supreme Councils are normally conducted by Grand Secretaries General. Brethren should therefore not attempt, without the Grand Secretary General's prior permission, to make direct contact with another jurisdiction.

# **ANNUAL DUES and FEES**

The Supreme Council has decided that the Annual Dues payable on 1<sup>st</sup> July 2014 will increase to £16.00 (plus VAT where applicable) for every subscribing member of each Chapter during all or part of the preceding year. Districts overseas (except where special arrangements apply) will remit £12.50 per subscribing member, retaining the balance of £3.50 to help defray District costs.
